## PART-I

### DEPARTMENT OF LEGAL AND LEGISLATIVE AFFAIRS, PUNJAB Notification The 16<sup>th</sup> January, 1997

**No.1- Leg/97-** The following Act of the Legislature of the State of Punjab received the assent of the Governor of Punjab on the 11<sup>th</sup> January, 1997, and is hereby published for general information:-

#### **The Punjab Technical University Act, 1996 (Punjab Act No.-1 of 1997) AN ACT**

*To provide for the establishment and incorporation of a University for the advancement of Technical Education and development thereof in the state of Punjab and for matters connected therewith.*

Be it enacted by the Legislature of the State of Punjab in the Forty-seventh year of the Republic of India as follows:-

1.	(1) This Act may be called the Punjab Technical University Act,1996 (2) It shall come into force at once.	<i>Short title and commencement</i>

In this Act and in all regulations made hereunder, unless the context otherwise requires:- (a) "college" means a college or an institution maintained by or admitted to the privileges of the University under this Act; (b) "member" means a member of the Board of Governors established under this Act and includes its Chairman; (c) "Principal" means the Head of a College( by whatever name he may be called) and includes when there is no Principal the person for the time being duly appointed, to act as Principal, and in the absence of the Principal or the acting Principal, a Vice Principal duly appointed as such (d) "Regulations" means the Regulations of the University made under this Act (e) "Technical Education" means the education in the subjects of Engineering Technologies, Sciences, Management, Humanities, Pharmacy, Social Sciences and Architecture and such other subjects as may be deemed fit by the State Government from time to time, and (f) "University" means the Punjab Technical University, Jalandhar as incorporated under this Act.	<i>Definitions</i>

(1) The first Chancellor and the first Vice Chancellor of the University and the first members of the Board of Governors and the Academic Council and all persons who may hereafter become such Officers or Members so long as they continue to hold such office or membership are hereby constituted a body corporate by the name of "The Punjab Technical University, Jalandhar" (2) The University shall have perpetual succession and a common seal with power to acquire hold and dispose of property, and to contract, and may by the said name sue and be sued.
